Subject: Information requests in follow-up to the decisions taken by the Conference of the Parties to the Rotterdam Convention at its sixth meeting

Dear Sir/Madam,

I am pleased to inform you that at its sixth meeting held in Geneva, Switzerland from 28 April to 10 May 2013, the Conference of the Parties to the Rotterdam Convention agreed on the decisions contained in annex I to the meeting report, set out in document UNEP/FAO/RC/COP.6/20. The report is available on the Rotterdam Convention website: www.pic.int. Some of the decisions include invitations to parties and others to provide information.

This letter is to solicit information sought in the decisions adopted by the Conference of the Parties to the Rotterdam Convention at its sixth meeting. To facilitate your response, attached are the individual requests organized according to the decision references. Information regarding each decision can be submitted separately, particularly since the deadlines for submission vary.

The letters and requests contained therein are made available in the section "<u>Call for information and follow-up to the sixth meeting of the Conference of the Parties</u>" of the Convention's website. Relevant forms for the purpose of communicating information to the Secretariat will also be made available on the Convention's website at the link provided.

Similar letters have also been prepared to solicit information sought in all of the decisions adopted by the Conference of the Parties to the Basel Convention at its eleventh meeting and by the Conference of the Parties to the Stockholm Convention at its sixth meeting. These letters are available in the "Call for Information" sections on the respective conventions' websites.

In addition to requests for submitting information, the Conference of the Parties to the Rotterdam Convention has reminded parties to ensure the effective implementation of the Convention, including the procedures under Articles 5, 6, 10 and 12 of the Convention, and, in particular:

- To exchange information in accordance with the provisions of the Convention, by submitting notifications of final regulatory action for banned or severely restricted chemicals;
- If they have not yet done so, to submit import responses for alachlor, aldicarb and endosulfan, or to request the Secretariat for assistance if deemed necessary.
- Exporting and importing parties to fully implement Article 12 of the Convention by sending export notifications and by acknowledging their receipt.
