At the 7<sup>th</sup> meeting of the Conference of the Parties to the Rotterdam Convention, Parties called on the Secretariat to address problems in submission of import responses stemming from Parties employing different definitions of pesticides. Following this request, the Secretariat sent out a questionnaire in 2016 to seek information from Parties. At the 8<sup>th</sup> meeting, the Conference of the Parties in further considering the matter, agreed that the work on the survey on different definitions and the preparation of a comprehensive analysis of the responses and a description of the potential implications of the use of different definitions including options for how to address them should continue.
