* All but one member of the Contact group had agreed that the notifications from the Sahelian countries and the European Union met all criteria of Annex II. 75. The Committee agreed that, since no consensus had been reached that the notifications from the European Union and the Sahelian countries met the criteria set out in Annex II to the Convention, further consideration of the item would be deferred to the Committee's next meeting. The document setting out the rationale and opposing arguments in respect of the Annex II criteria as applied to atrazine would be posted on the Convention website as document UNEP/FAO/RC/CRC.11/INF/18.
