## **Status of official contact points**

### **Note by the secretariat**

1. At its second meeting, the Conference of the Parties considered a note from the secretariat regarding official communication with Governments. The Conference noted that the entry into force of the Convention provided an opportunity to improve the efficiency and timeliness of communication with Parties and with non-Party Governments, as well as observers, and to bring communication practices into line with the provisions of the Convention and the rules of procedure. Consequently, the Conference requested the secretariat to write to Governments asking them to provide contact details for their official contact points for the Rotterdam Convention and to agree to the posting of those details on the Convention website.
2. The secretariat contacted all Governments, using the lists of official contact points of the United Nations Environment Programme and the Food and Agriculture Organization of the United Nations, inviting them to provide contact details for their official contact points for the Rotterdam Convention. The resulting list of official contact points for all Governments (both Parties and non-Parties) was used for the distribution of all official documents relating to the third meeting of the Conference of the Parties and is available on the Convention website. For Governments which have not yet nominated an official contact point, previously existing contact information is being used.
3. Attached for the information of the Conference in the annex to the present note is the list of the official contact points in relation to the Rotterdam Convention for all Parties and non-Parties.
