Subject: Questionnaire requesting information on exports, export notifications and information exchange-Year 2017

Dear Designated National Authority,

At its seventh meeting held in 2015, by decision RC-7/2, the Conference of the Parties to the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade requested the Secretariat to facilitate the exchange of information and report to each meeting of the Conference of the Parties on the implementation of Articles 11 (paragraph 2), 12 and 14 of the Convention.

The Secretariat has developed a questionnaire to collect this information. It is available online on the Convention website at the last section of webpage "Call for information and follow-up to the ninth meeting of the Conference of the Parties to the Rotterdam Convention" at www.pic.int/tabid/5959/Default.aspx.

Designated National Authorities (DNAs) of Parties to the Convention are invited to respond to the online questionnaire with information corresponding to the period from 1 January 2017 to 31 December 2017 by **15 December 2018**.

The responses to the questionnaire will be compiled by the Secretariat and reported to the Conference of the Parties at its next ordinary meeting.

DNAs are invited to collaborate with other DNAs, Official Contact Points (OCPs) and any other relevant stakeholders in order to provide a coordinated response to the questionnaire if feasible.

The responses to the questionnaire for the year 2015 received from Parties were reported to the Conference of the Parties at its eighth meeting through document UNEP/FAO/RC/COP.8/INF/10. If your country has submitted information for that year, you may wish to refer to the above document for such information to facilitate completing some relevant sections of the questionnaire for year 2017.


